**Course Description:** This course focuses on fluctuations in a nation's level of economic activity, and their impacts on the economic well-being of citizens.

**Course Objectives/Learning Outcomes:** This course will enable students to understand macroeconomic issues that arise in daily life.

**Course Outline:** Students will learn about the following topics, some of which may be deleted depending on time constraints:

1. Macroeconomic Foundations and Long-Run Growth Chapters 4 – 7

2. Short-Run Fluctuations Chapters 8 – 9 and Appendices C and D

3. Monetary and Fiscal Policy Chapters 10 – 13
4. The International Economy Chapters 14 - 15
