4. The IS-LM / AD-AS Model, Chapters 10, 11, and 12
5. Exchange Rates, Business Cycles, And Macroeconomic Policy in the Open Economy, Chapter 13.

Each assignment is due at the beginning of the lecture on the due date. Late assignments will ever be accepted.

The midterm exam will be held in class on the date indicated. The time and location of the final exam, which will be two hours in length, will be scheduled by the Registrar's Office. Exam questions will not consist of multiple choice questions. The use of a simple non-programmable calculator during exams is permitted - **business calculators, engineering calculators, scientific calculators, etc. are not allowed.**

The midterm exam, assignment, and the final exam are marked on a numerical basis. The grades are then added using the weights indicated above. As a guide to determining standing, these letter grade equivalences will generally apply:

Notes:

1. Make-up midterm exams and deferred midterm exams will not be given. Deferred final examinations do not have to cover the same material or have the same format as the regular final examination.

2. Examinations will not be given prior to the scheduled date.
