Course Description

This is an intermediate level course in macroeconomics. You will be presented with different types of economic models that economists use to better understand how the economy operates and how governments, may or may not, be able to influence macroeconomic outcomes. These outcomes would include higher employment levels, disposable income of households, investment spending and corporate profits to mention a few. Our focus in Macroeconomics 303 is on the nature of the business cycle. In particular, we will try to gain an understanding of what causes temporary expansions and contractions of different phases of the business cycle.

The course grade is calculated using the weights indicated above. The cut-off between letter grades will be at the midpoint between the numerical grades. A passing grade on any particular component of the course is not required for a student to pass the course as a whole.

- 2. Assignments and tests are intended to be challenging and as a result, you are encouraged to consult your classmates when working on assignments. If after reading the assignment and after consulting your classmates, you are still having trouble with the assignment, please show your TA your effort and the TA will help you get on track. If you are still having problems, please come and see me during office hours and I will help you. Taking credit for someone else's work will result in a zero for that assignment.

Tutorials

The tutorials will be 50 minutes in duration and these tutorials will allow the student to work on problem sets and clarify various economic concepts. The problems will not be graded but they do offer you the opportunity to test your understanding of the material. Furthermore, graded assignment questions will be similar to the problem sets given in the tutorial so your participation is highly recommended. The starting date of the tutorials will be announced in class.

There will be a Registrar scheduled final examination, held in a classroom, lasting 2 hours. Non-programmable calculators will be allowed during the writing of midterm or final examinations.

Tests and exams <u>WILL NOT</u> involve multiple choice questions.

A student who feels that a piece of graded term work (e.g., term paper, essay, test) has been unfairly graded, may have the work re-graded as follows. If not satisfied, the student shall immediately take the matter to the Head of the department offering the course, who will arrange for a reassessment of the work within the next 15 days.
