Grade Determination and Final Examination Details:

A passing grade on any particular component of the course is not required for a student to pass the course as a whole.

Non-programmable calculators WILL be allowed during the writing of tests or final examinations.

There will be a Registrar scheduled final examination, held in a classroom, lasting 2 hours.

Tests and exams WILL NOT involve multiple choice questions.

Notes:

- Examinations will not be given prior to the scheduled date. The midterm examination will be held during lecture time in class. No deferred midterms will be given.
- Students who are unable to write the midterm because of an illness, family emergency or religious observance will have the midterm weight shifted to the final examination. This adjustment will result in the final exam counting for 80% of the final grade and the assignments counting for 20% of the final grade. Documentation MUST be provided.
- Examinations will consist of short (open ended) and long problems. The examinations will be closed-book. The use of graphing calculators, cell phones, computers, and other electronic devices will not permitted. The final examination will be a comprehensive exam of all material covered in the course.
- The assignments will be posted on the D2L. The due date for the assignments will be announced in class.
- Students will be responsible for all material listed on the course outline, regardless of
 whether or not the material has been covered in class, unless the instructor notifies the
 class that the material will not be covered.
- All students must comply with the regulations published in the University Calendar concerning "Intellectual Honesty," "Examinations," etc.
