Course Outline:

This is an intermediate level course in macroeconomics. You will be presented with descriptions of the economy (what economists call "models") that macroeconomists use to better understand how the economy operates and how governments may, or may not, be able to influence macroeconomic outcomes. Our focus in Economics 303 is on the nature of the business cycle. In particular, we will try to gain an understanding of what causes temporary expansions and contractions of output and employment, temporary accelerations or slowing of inflation, rises and falls in exchange rates, etc.

The midterm test will be held in the classroom during regular lecture hours. The final exam will be two (2) hours in length, will be conducted in a larger classroom, and will be scheduled by the Registrar's Office. There will be no multiple choice questions on either tests or on the final exam. Use of a calculator during either tests or the final exam will not be allowed.

Tests and final exams are marked on a numerical (percentage) basis, then converted to letter grades. The course grade is then calculated using the weights indicated above. As a guide to determining standing, these letter grade equivalences will apply:

A passing grade on any particular component of the course is not required for a student to pass the course as a whole.

Non-programmable calculators WILL NOT be allowed during the writing of tests or final examinations. There will be a Registrar scheduled final examination, held in a classroom, lasting 2 hours.

Tests and exams WILL NOT involve multiple choice questions.

Notes:

- Students should be aware that no "make-up" midterms will be given. Any student who finds it
 necessary to miss the midterm must notify the instructor in advance and produce a valid
 medical certificate or other required documentation in order to have the weighting adjusted.
 This adjustment will result in the final exam counting for 75% of the final grade and the
 assignments counting for 25% of the final grade.
- 2. Examinations will not be given prior to the scheduled date.
- 3. Answers to the midterm test, the assignment and the final exam questions must make use of equations and diagrams wherever possible. Numerical questions require numerical answers.
- 4. Students will not be given extra time to complete tests and exams.
- 5. Students should be aware of the academic regulations outlined in The University of Calgary Calendar.
