Course Outline:

This course provides an overview of the theory and practical functioning of the Canadian federal and provincial governments in relation to the broader Canadian Economy. Course content will be a mixture of economic theory and practical discussion with the latter related to contemporary issues in public finance.

As a field course in economics, Econ 355 will make extensive use of the analytical tools developed in prerequisite economics courses (Econ 201 and 203).

It is my responsibility to teach this material in a clear and understandable format, and it is your responsibility to learn this material and to be able to demonstrate to me that you have learned it. Both inside and beyond the classroom the ability to communicate economic concepts is as important as the ability to understand economic concepts. Also, I cannot tell if you understand the course material unless you can explain it back to me.

- 1. Review of Econ 201/203 and introduction to the core concepts of public finance.
 - Incidence of taxation and deadweight loss.
 - Government spending and national income accounting.
 - Welfare economics
- 2. Public Expenditure(theory)
 - public goods and other market failures
 - efficiency and equity
 - fiscal policy (recession economics and other macroeconomic issues)
- 3. Public Expenditure (practical)
 - Education
 - Health Care
 - Transfer Programs (employment insurance, welfare and pensions)
- 4. Government Revenue (theory)
 - Taxes
 - Royalties
 - Deficit financing
 - User fees and privatization
- 5. Government Revenue (practical)
 - Personal income tax
 - Consumption based taxes
 - Wealth and property tax
 - Corporate income tax
 - Non tax sources (Resource royalties, asset sales, etc.)
