Course Outline:

This course analyses microeconomic aspects of the globalization phenomenon. In so doing, it provides a detailed

explanation of trade flows, gains from trade and trade policy measures and goes on to consider issues such as: strategic trade policy in the presence of imperfect competition; trade and technological change; trade-related aspects of intellectual property; and trade, trade policy and the environment.

Economics 425 complements Economics 321, "The Global Trading System", by providing more breadth and depth. While Economics 321 is NOT a prerequisite to Economics 425, it does provide very helpful background. Students must either complete ECON 357 prior to or concurrently with ECON 425 OR complete ECON 309 prior to ECON 425.

A course syllabus listing topics and accompanying readings will be made available during the first week of class. An agenda of topics for the day and accompanying readings will be announced in each class.

Grade Determination and Final Examination Details:

All students must comply with the regulations published in the University Calendar concerning "Intellectual Honesty," "Examinations," etc. Students must successfully pass the final examination to pass the course. Students will normally be evaluated in accordance with the marking scheme given below:

If the distribution of grades determined using the conversion chart shown above appears to be abnormal, the instructor reserves the right to change the grade conversion chart in order to more fairly represent student achievement.

- The <u>final examination</u> will be scheduled by the registrar and held in a classroom. The final examination will be designed to be written in two hours, but students will be permitted two and one half hours of writing time. The FULL COURSE will be covered. Deferred final examinations will not be given except in situations of extreme personal emergency. Final examinations and deferred final examinations will only be held at the time, date and location set by the registrar.
- The <u>midterm examination</u> is tentatively scheduled for the regular class session on Wednesday March 8, 2007.

Deferred midterm tests will not normally be given. Students who are unable to write the midterm because of illness, family emergency or religious observance will have the midterm weight shifted to the final. Appropriate DOCUMENTATION is required in all such cases.

• There will be <u>two reports</u>. Both reports will require an essay-style write up. The reports will typically require research and/or data analysis. Both the content and written presentation of the assignments will enter into the evaluation. Reports that do not meet university standards for documentation and/or effective writing will receive a grade of zero.

The final and midterm examinations will consist of various types of short answer questions, short essays, and/or problems. There MAY also be multiple choice questions. The use of non-programmable calculators will be permitted.
