## **Course Outline:**

The student will learn about research methods and analytical approaches in applied energy economics. The course will equip the student with an understanding of the essential business and policy concepts in applied energy economics relating to natural gas and electricity. Current topics of importance will be covered.

Students will be evaluated by the instructor on the basis of two major group assignments. The first assignment shall be worth 40% of the final grade, with the second assignment being worth 60%. will be submitted for all group members, and further disciplinary action may be taken.

Marks will be assessed in percentage terms and then converted to letter grades.
