Course Description

The purpose of this course is to introduce students to the fundamental issue of empirical economics: identifying and estimating causal effects. Almost any work in empirical economics (and social science in general) is about questions of cause and effect such as: Do small class sizes cause students to perform better? To what extent are the different levels of economic growth observed worldwide caused by different colonial institutions imposed on countries in the distant past? Does imposing a female policy-maker through gender quotas cause a change in policy? Does raising the minimum wage cause unemployment to increase? Does listening to hate-speech on the radio make people more likely to participate to a genocide? While we would ideally run a controlled experiment to answer these questions, this is often not possible. Therefore, we need to use special methods and techniques. In this course we will develop and study these techniques, as economists have used them to answer the questions they are interested in.

The course follows the textbook quite closely. Specifically, we will cover the following topics.

- 1. The Experimental Ideal (CH. 2)
- 2. The Simple Linear Model (CH. 3)
- 3. Instrumental Variables (CH. 4)
- 4. Panel Data: Fixed effects and Differences in Differences (CH. 5)
- 5. Regression Discontinuity Design (CH. 6)
- 6. Quantile Regression (CH. 7)
- 7. Additional Topics (Time Permitting)

Prerequisites/corequisites

Econ 497 starts at a level that assumes familiarity with the material covered in Econ 495 and Stats 213, including proficiency at mathematical statistics and some calculus. We will make use of matrix algebra. While we review key results in class, students may find a review using econometric textbook appendices useful. Students with weak math backgrounds will especially benefit by taking the recommended math courses.

The applied component to this course requires the use of STATA software. Students are required to use STATA software on assignments, and should expect to be tested on basic coding and output. Computers in the Tri-Faculty computer lab (SS018) are equipped with STATA.

A student who feels that a piece of graded term work (e.g., term paper, essay, test) has been unfairly graded, may have the work re-graded as follows.
