Grade Determination and Final Examination Details:

Test 1 will be held on June 3 and will count for 45% of your final grade. Test 2 will be held on June 17 and will count for 45% of your final grade Test 3 will be held on June 24 and will count for 10% of your final grade. Tests and final exams are marked on a numerical (percentage) basis, then converted to letter grades. The course grade is then calculated using the weights indicated above. As a guide to determining standing, these letter grade equivalences will apply:

A passing grade on any particular component of the course is not required for a student to pass the course as a whole.

Non-programmable calculators WILL be allowed during the writing of tests or final examinations.

Notes:

- 1. Students should be aware that no "make-up" tests will be given. If a student does not write the final test on June 24, the student must apply for a deferred final exam. A deferred final exam will not be given except in cases of extreme personal emergencies. If, for such a reason, a deferred final exam is allowed by the Registrar's Office, it will not be given before the scheduled deferred exam date. Deferred final examinations do not have to cover the same material or have the same format as the regular final examination.
- 2. No test will be given prior to the scheduled date. Any student who finds it necessary to miss Test 1 and/or Test 2 must notify the instructor in advance and produce a valid medical certificate or other required documentation in order to have the weighting adjusted. This adjustment will result in the weight assigned to the missed test(s) being added to the final test weight.
- 3. Answers to the tests must make use of equations and diagrams wherever possible. Numerical questions require numerical answers.
- 4. Students will not be given extra time to complete the tests.
- 5. Students should be aware of the academic regulations outlined in The University of Calgary Calendar.
- 6. The use of cell phones for any purpose in class is prohibited. The classroom is a no cell phone zone. Computers may only be used for note-taking purposes.
- 7. Students seeking reappraisal of a piece of graded term work should discuss their work with the instructor within 8 days of work being returned to class.
