Course Outline:

The objectives of this course are:

- a) To develop an understanding of the resource base, the evolution of the overall structure and functioning of the provincial economy.
- b) To acquaint the student with the relevant constraints (institutional, technological, economic, environmental etc) and policy issues respecting the present structure of the provincial economy and future industrial development and growth alternatives.
- c) To develop a set of analytical tools to assess projects and tools to evaluate various provincial economic development and growth strategies.

A detailed course outline will be posted on Blackboard at the beginning of the term.

The midterm exam will be held in class on the date indicated. Tests and final exams are marked on a numerical (percentage) basis, then converted to letter grades. The course grade is then calculated using the weights indicated above. As a guide to determining standing, these letter grade equivalences will generally apply:/3
