#### **Course Outline:**

This course extends and complements ECON 619/621 by examining trade theory and empirical analysis of trade theory. ECON 619/621 provide the theoretical context and models that form the basis for Econ 611.66 which examines important longstanding as well as contemporary issues in international trade policy.

The course will be conducted as a seminar and will require class participation and involvement including class presentations.

A list of topics and accompanying readings will be made available during the first week of class.

## **Grade Determination and Final Examination Details:**
