Course Outline:

This is a course in microeconomic theory. The goal of the course is to give you a solid grounding in the theory of consumer choice and producer behavior, while giving you some familiarity with equilibrium outcomes in competitive markets and social welfare. The course is pure theory, with no empirical component. It covers the logical skeleton of microeconomics to ensure you have a good understanding of this skeleton. The course will focus on definitions, propositions and proofs. The course provides the set of tools for you to employ in field courses, where more applied topics are taught.

The course will cover approximately the first six chapters in *Advanced Microeconomic Theory Microeconomic Theory* by Jehle and Reny, supplemented by some examples from various other sources. The book is available in the bookstore for you to purchase and the course will follow the book quite closely. *You should also read the mathematical appendix to this book during the course.* Additional resources have been placed on library reserve. The topics and chapters from Jehle and Reny are as follows:

- Chapter 1. Consumer Theory
- Chapter 2. Topics in Consumer Theory
- Chapter 3. Theory of the Firm
- Chapter 4. Partial Equilibrium
- Chapter 5. General Equilibrium

Grade Determination and Final Examination Details:
