Course Description:

Economics 401 focuses on the expenditure side of public finance (Economics 403 deals with the taxation side). The course examines the main government expenditure programs in Canada: health care, education, employment insurance, public pensions, etc. We will also consider income inequality and redistribution, including discussions on the rising income share of the top 1 percent. Coverage of the topics will consist of a presentation of institutional facts and a development of the economic theory (public goods, welfare economics) required for understanding the economic purposes of the government programs. The course will follow a fairly pragmatic, policy oriented approach. Some of the material is more technical and requires knowledge of Intermediate Microeconomics theory. Class discussions are encouraged. Check D2L for the postings of some of the readings.

By the end of the course students should be able to understand and critically evaluate issues related to social and government policy from an economic perspective.
