### Course Description

The general equilibrium treatment of the gains from trade, comparative advantage and trade patterns provides a basis for examining topics such as: trade policy under imperfect competition, trade policy and the environment, trade policy and economic growth, and preferential trading arrangements.

Topics covered in the course:

Chapter 1: Trade in the Global Economy  
Chapters 2, 3, 4, 5: Patterns of International Trade  
Chapter 6: New explanations for international trade  
Chapters 8, 9, 11: International trade policies

Note: Some topics will be added or deleted depending on time constraints.

### Course Objectives/Learning Outcomes

This course on International trade is fundamental to understanding the growth and evolution of the international economy. In this course we will use theories to illustrate why countries engage in trade, what determines the trade patterns and what the normative and positive aspects of trade are? Some of these theoretical models include the Ricardian model, the Heckscher-Ohlin model, trade models with economies of scale etc. These theoretical models will form the basis for our analysis of various trade policies (examples: import tariffs, quotas and various regional and global trading arrangements such as the North American Free Trade Agreement-NAFTA and the World Trade Organization-WTO respectively) and we will extend our analysis to include social, political, environmental etc. factors that play a crucial role in the trade policy formulation.

A student who feels that a piece of graded term work (e.g., term paper, essay, test) has been unfairly graded, may have the work re-graded as follows. The student shall discuss the work with the instructor within 7 days of being notified about the mark or of the item's return to the class; no reappraisal of term work is permitted after the 7 days. If not satisfied, the student shall immediately take the matter to the Head of the department offering the course, who will arrange for a reassessment of the work within the next 7 days. The reappraisal of term work may cause the grade to be raised, lowered, or to remain the same. If the student is not satisfied with the decision and wishes to appeal, the student shall address a letter of appeal to the Dean of the faculty offering the course within 7 days of the unfavourable decision. In the letter, the student must clearly and fully state the decision being appealed, the grounds for appeal, and the remedies being sought, along with any special circumstances that warrant an appeal of the reappraisal. The student should include as much written documentation as possible.
