#### **Course Outline:**

This advanced undergraduate course in Economics will focus on contemporary issues in international trade policy.

Economics 357 and 359 are required prerequisites. Economics 321 and/or 425 are useful for background, but not required.

The course will be conducted on a predominantly independent study basis but the following class meetings are planned:

1. **Breadth Components:** There will be an assignment that focuses on the game-theory-understanding of the conduct of international trade policy in chapter 6 of the Kerr and Gaisford *Handbook*. The Assignment will be due June 2.

In addition to the assignment, there will be 12 (twelve) 600-word reading summaries (approximately two double spaced pages). The summaries, which will be based mainly on the chapters in the *Handbook*, should highlight the main themes and issues arising from the readings. The entire *Handbook* will be covered by the summaries and assignment.

- S8 *Handbook*, Chapters 26-31, due on or before June 30
- S9 *Handbook*, Chapters 32-35, due on or before June 30
- S10 *Handbook*, Chapters 36-38, due on or before July 14
- S11 Handbook, Chapters 41-44, due on or before July 14
- S12 *Handbook*, Chapters 46-48, due on or before July 14
- 2. **Depth Components:** There will be a 5000-word term paper (approximately 15 double spaced pages). The term paper will be due July 16. Topics will typically be chosen from: (a) issues concerning trade and the environment, (b) international trade disputes or (c) other areas of interest in the readings.

Students will be required to submit a proposal by May 30. Proposals will consist of: (a) a topic paragraph, (b) a provisional outline (in clear point form), and (c) a preliminary reference list (with at least five scholarly references and one-sentence annotations).

Students will also be required to make a 15-minute presentation of their topics on Wednesday June 16 (date subject to change). ). Presentations will be posted on blackboard.

#### **Notes:**

- Students seeking reappraisal of a piece of graded work should discuss this with the instructor within two weeks of the work being returned. At the instructor's prerogative, a remedial assignment for partial credit may be requested of students who have attempted a piece of work without achieving a passing grade.
