Course Description:

This is the second part of the core PhD course in macroeconomics. The course is intended to introduce some selected macroeconomic issues, as well as to demonstrate how to use analytical models and techniques to examine the issues. Both the issues and the models should be treated as important components of the course.

Course Objectives:

The main purpose of this course is to prepare students to conduct research in macroeconomics.

Course outline:

The course is organized into two parts. The first part focuses on equilibrium models of the labor market. The second part introduces a few selected topics in macroeconomics.

- Topics in macroeconomics
